

2021 PICKLEBALL SCHEDULE & RULES

Modified September 13, 2021

The pickleball courts and complex are set up to entertain members, their families and guests following the procedures created in this document. With the increased interest in pickleball from our members, we will review policies and modify our programs from time to time. The club started with two pickleball courts located at tennis. We now have courts 1-4 in the new pickleball complex by the dog park/community garden. We also now have two other courts 5-6 dedicated to pickleball on the upper tennis court and one pickleball court on the lower tennis court. This document will outline member play, court usage, guest play, and the use of the courts in all other open times. The pickleball annex will be governed as a "club amenity" with all 7 courts falling under these guidelines. All bookings will be through expanded club reservation application (Foretees which will be launched in November 2021)

I. Designated Member Play Times

Member play will begin as outlined below. Courts 1-4 will be used for all member designated play. 7 AM will be the earliest start time daily.

- ♦ It is encouraged that courts 1-2 would be used for beginner and intermediate play during these seasonal times.
- ♦ Courts will be for only designated member group.
- ♦ Guests will not be allowed as this is a designated member play only time.
- ♦ Family Guests would be eligible to play in open member times due to their membership status.
- ♦ Lessons and instruction will also be limited during this time to courts 5-7 in upper court area which will be open to all members booking and reserving courts.

2. Lesson Structure and Programming

With pickleball designated as a club amenity all lessons and instructors must be launched through club's listed available instructors. The club has a current instructor program and all outside vendors would need to register as an independent contractor and fall under the club's lesson program parameters. Lessons under any situation from outside vendors not registered should be taken at the location of the instructors or on private pickleball courts. All club instructors are independent contractors and are required to provide proof of liability insurance to be on club's courts instructing and fall under lesson programming for all venues. Lessons are subject to the current club's program for independent contractors and may change from time to time. Instructors must be listed with Andee.

- A. Lesson programs during the times of open play should all commence on the open courts 5-7 or be scheduled during all open times by booking the appropriate court and time reservation with Foretees (when available). Lessons may be taught on courts 1-4 following designated member play times
- B. During interim time (prior to Foretee launch), all lessons and court availability should be reserved with Andee and her staff in fitness/court programming.

3. Guest Policies at Talking Rock Pickleball

Guest play will be allowed during all times not falling under member play times from 7 AM – 11 AM as outlined in Designated Member Play Times. Guests will be allowed to play under a complimentary day pass but must be with the host member to use TR courts. NO OUTSIDE GUESTS will be allowed to use Talking Rock courts without a member presence.

A. Under these requirements there will be no limit to number of guests a member may invite to play.

B. Courts & Guest play will be limited to one - hour increments. Should no one have the times following a member hour slot the courts may be used for an additional amount of time until a reservation occurs.

C. Guest usage will be monitored and shouldn't be abused by any member of the club where it may impact or interfere with member usage.

D. Guest usage will be approved by Andee and her designated staff for all guest usage and play. Until Foretees booking engine is launched all reservations will be kept in fitness/ court programming.

4. Open Play Times and Procedures

Members and their guests will be allowed to use courts 1-4 during all other times not designated for member use and may use courts 5-7 at any time each day. Members will be limited to one hour of court usage. Should the court you're on or any other court remain open following member's hour you may move to that court to play. All play will be through bookings with Andee or application taking precedence over anyone on courts. Please make court reservations by emailing Andee and her team at fitness@talkingrockclub.com until the Foretees reservation program launches.

We will NOT be monitoring court usage during the day but may have a staff member check from time to time on all member usage. Members should raise any concerns to staff rather than personally interact with members or confront members. This is like all other club amenity situations. Please be respectful to one another and when a situation arises that is not currently outlined in this document do what is fair to everyone involved and reach a compromise in a respectful manner. We will run our new policies through year end 2021 and reevaluate for any further concerns or impacts...enjoy the courts.
